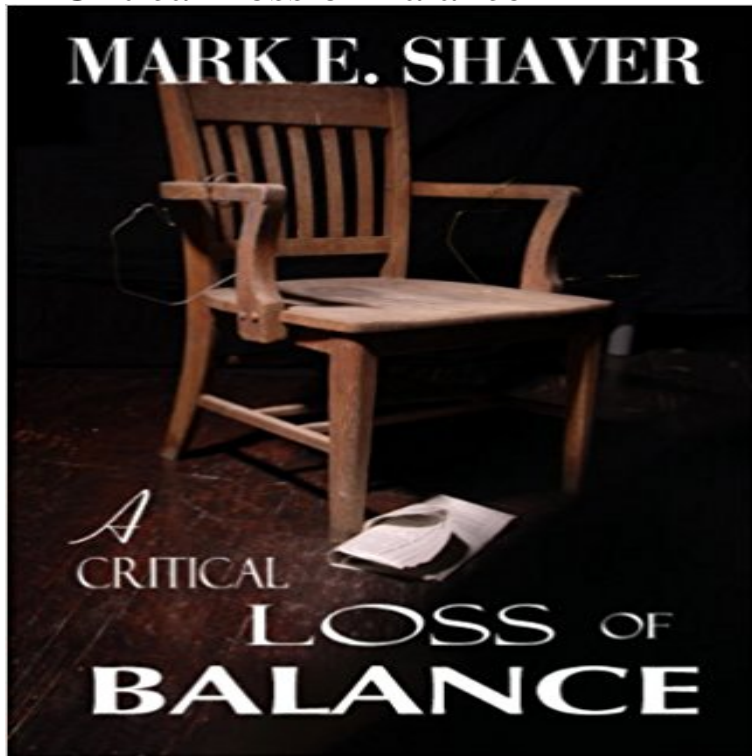


A Critical Loss of Balance
