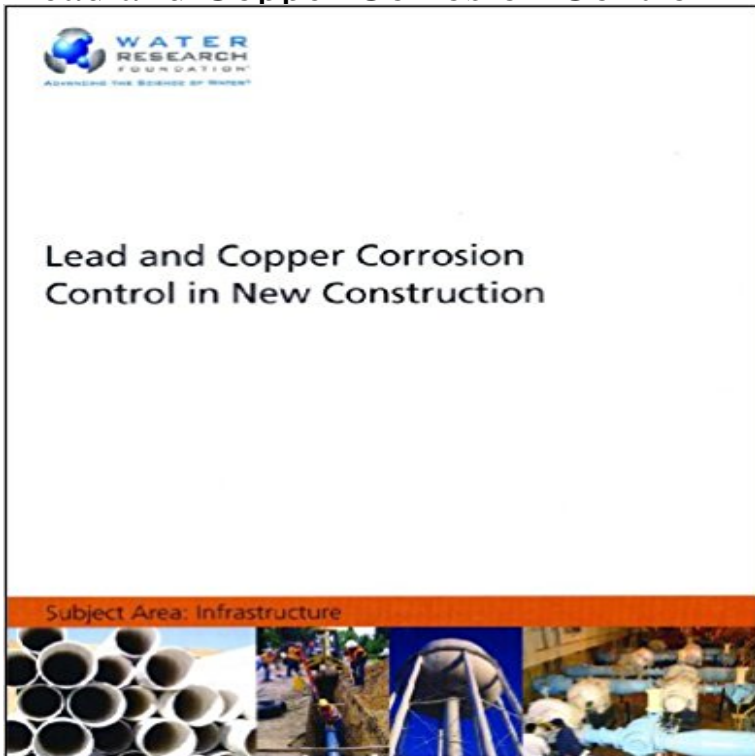


Lead and Copper Corrosion Control in New Construction
